

## **Abstract Submission Rules and Copyright Policy**

### **1- Introduction**

These Abstract Submission Rules and Copyright Policy govern the submission, review, and acceptance of abstracts for the 3rd Emergency Physician's International Conference (EPIC24) - Evidence-Based Emergency Medicine (EBEM) hosted by From Zero to Hero Website. By submitting abstracts to the conference, you acknowledge and agree to comply with these rules and policies.

### **2- Submission Process**

Abstracts must be submitted electronically through the conference website within the specified submission period.

Authors are required to provide accurate and complete information, including author names, affiliations, contact details, and abstract content.

### **3- Content Guidelines**

Abstracts must adhere to the specified format, word limit, and content guidelines outlined on the conference website.

Authors are responsible for deidentifying patient details and obtaining consent for images (if needed) before submission. Any abstract containing identifiable patient information without consent will be rejected.

The absence of necessary consent or approval will result in the rejection of the abstract or later withdrawal of its acceptance. Similarly, the presence of identifying data will lead to the rejection of the abstract or later withdrawal of its acceptance.

Abstracts must not contain pharmaceutical or industry logos or conflicts of interest. Abstracts found to contain such materials will be removed from consideration.

### **4- Conflict of Interest Policy**

The presence of any conflict of interest will mean rejection of your abstract or later withdrawal of your acceptance. Authors must disclose any potential conflicts of interest related to the subject matter of their abstracts at the time of submission.

## **5- Previous Publication Policy**

If this abstract submission was previously published in a journal or presented in a national or international conference, it might be rejected or not accepted. The conference prefers that abstracts are not published in a journal or presented in a national or international conference before the EPIC 2024 conference date (10/7/2024). Authors must confirm the originality of their submission and disclose any prior presentations or publications of the material.

## **6- Review Process**

Submitted abstracts will undergo a peer-review process conducted by at least two members of the Scientific Committee.

The review process will assess the scientific quality, relevance, and originality of each abstract.

## **7- Notification of Acceptance**

Authors will be notified of the acceptance status of their abstracts within the specified timeframe.

Accepted abstracts will be published as PDFs on the conference website and may be exhibited on other digital platforms, as outlined in the Privacy Policy and Terms of Use.

## **8- Presentation Selection**

Top-scoring abstracts will be selected for oral presentation during the conference's main program.

E-posters with outstanding quality and significance will be chosen for display on the conference website and other digital platforms.

## **9- Copyright Policy**

By submitting an abstract to the conference, authors grant the conference organizers the right to display, reproduce, and distribute the abstract for conference-related purposes, as outlined in the Privacy Policy and Terms of Use.

Authors retain copyright ownership of their submitted materials and may reproduce, distribute, or display them for personal or professional purposes, provided proper

attribution is given to the conference and acknowledgment of initial publication at the conference is provided. The conference organizers will not transfer or sublicense copyright to third parties without prior consent from the authors.

#### **10- Data Retention**

Personal information provided with abstract submissions will be retained for the duration necessary to fulfill the purposes outlined in the Privacy Policy.

The abstract submission process is free from discrimination based on factors such as race, ethnicity, gender, religion, nationality, or affiliation. There are equal opportunities for all participants.

#### **14- Confidentiality Assurance**

The review process will be conducted confidentially, and submitted abstracts will be treated with confidentiality.
